Doctoral programme of Law

Admission requirements

Applicants to the Doctoral School of Law must have a university degree (MA) in law and an intermediate state-accredited language exam in one of the following languages: English, German, Russian, French, Spanish, Italian (or knowledge of one of these languages equivalent to an intermediate state-accredited language exam). In case of university degree acquired abroad the decision of the Hungarian authorities about the equivalency with a university MA degree in law may be required, too.

Candidates can apply before their final examination in case they would pass it at least until 3 July, 2025.

Applicants to the individual (correspondence) training must have a university degree (MA) acquired at least three years before the application deadline. Besides fulfilling the general conditions they must take research activity as part of their work and have a considerable number of publications.

Foreign students can apply to the individual (correspondence) training, too. They must have a university degree (MA) in law.
