Please bring all of the following to enrolment without exception (failure to do so will prevent you from completing enrolment):

- Original **school-leaving certificate(s)**, **diploma(s)**, or a notarised copy thereof, along with one **photocopy** (the photocopy will be retained by the Academic Office after verification);
- Original **language examination certificate(s)**, or a notarised copy thereof, along with one **photocopy** (the photocopy will be retained by the Academic Office after verification);
- **identity document** (photocopy not required);
- **enrolment form** – register in Neptun, fill in your details, print the completed form, and bring it to enrolment.

At Eötvös Loránd University, student administrative matters are handled through the Neptun **Unified Study Administration System**. You will need to use this system from the very first days, so please visit <https://www.elte.hu/en/current-students> as soon as possible, where you will find instructions on how to log in.

Registration and course registration are also conducted through Neptun. Please log in to the Neptun system and register. Enter your details and contact information all of the following accurately and completely, print the enrolment form, and bring it to enrolment. If you fail to do so, you will only be able to begin your studies after a new admissions procedure.

COURSE REGISTRATION

Only students who have registered as active in Neptun may register for courses.

Course registration begins on 28 August 2026 at 20:00.

Mandatory courses for first-year students are offered without a capacity limit and may be registered for at any time up until 16:00 on 11 September.

- Global and European Governance / LPE:GEG
- Legal Framework of Multi-level Governance / LPE:LFGM
- Regulation of International Transactions / LPE:RFIBT
- AI for Professional Practice / LPE:AI
- Writing, Reasoning and Professional Communication / LPE:WRP

Course registration **closes on Friday, 11 September 2026 at 16:00.**

LATE COURSE REGISTRATION

Until Friday, 18 September 2026, students may register for courses late by submitting a request to the Academic Office, subject to a service fee of HUF 5,000 per course. This deadline is a forfeiture deadline, **no course registration is possible after it has passed.**

The Neptun system does not verify whether you are eligible to register for a given course. This will be checked later by Academic Office administrators, who will remove any courses registered for without eligibility.
