

Title	<u>Legal Ethics and</u> Professional Responsibility

Brief description	This course offers a comprehensive examination of ethical principles, moral reasoning, and professional responsibility within the legal field. Split into three parts, it explores foundational concepts in ethics and morality, examines the ethical obligations specific to legal practitioners, and deals with the unique ethical challenges faced by judges.
	In the first part, led by Dr. Jakub Łakomy, students will engage with the core concepts of morality and ethics, as well as justice. Key philosophical frameworks—such as deontology, consequentialism, virtue ethics, and discourse ethics—are introduced to provide a foundation for ethical reasoning in law.
	The second part, taught by Prof. Przemysław Kaczmarek, addresses the social role and professional responsibilities of lawyers. Students will discuss the principles of professional ethics, including the moral responsibilities of lawyers within their relationships with clients, the implications of authority, and the distinct ethical standards expected in the legal professions.
	In the third part, Dr. Mateusz Wojtanowski focuses on the ethical responsibility of judges. This section covers established standards of judicial behavior, the dilemma surrounding judicial freedom of expression, and the ongoing debate on judges' roles in public discourse. Students will also analyze real-world disciplinary cases to understand the implications of judicial ethics and the boundaries of acceptable behavior in the judiciary.
	Through lectures, case studies, and discussions, students will gain insights into the moral and ethical

	landscapes that define the responsibilities of lawyers and judges in contemporary society.

	 4. Professional ethics - the concept, ethics of legal professions, the separatist thesis - 2 hours 5. Obedience and authority and moral responsibility of lawyers - 2 hours 6. Models of client - lawyer relations in the contemporary philosophy of morality - 2 hours 7. The role of the judge. The limits of judicial power - 2 hours
	Dr Mateusz Wojtanowski – 3 rd part: "Ethical responsibility of a judge".
	8. Outline of standards of judicial behavior: examination of the established standards of judicial ethics as set forth in constitutional and international law, as well as international soft law. – 2 hours
	9. The judge's freedom of expression as a dilemma of liberal democracy: the meeting will focus on the juxtaposition of civil rights and freedoms owed to all citizens (including judges) on the one hand, and specific restrictions on the behavior of judges on the other. The reasonable observer test will be presented as a potential remedy - 2 hours

	10. The question of challenging the culture of judicial silence: the proposal to broaden the permissible scope of judicial expression, which has emerged as a topic of discussion in several countries in recent years, will be examined. The discussion will focus on the participation of judges in public debates on legal issues and their generally understood involvement in social life 2 hours 11. Judicial ethics in the light of disciplinary case law: the class will discuss disciplinary decisions on unethical behavior by judges. The judgments will be drawn from a database maintained by Global Freedom of Expression, Columbia University – 2
